2024 Sailaway Sailing School Volunteer Counselor-In-Training (CIT) Application

Thank you for your interest in being a volunteer member of the 2024 Sailaway Sailing School Staff. If your application is accepted, you'll be helping out, learning and having fun this summer as part of our team. You will also have the chance to improve your own sailing skills, to make friends and open the door to additional opportunities on and off the water.

The Counselor-In-Training (C.I.T.) position is a learning opportunity for a limited number of our most advanced sailing students. The goal of this C.I.T. program is to refine your sailing skills while learning how to be a good Counselor. If you do well as a C.I.T. it is our hope that you will return in future years to work as a paid employee.

Our C.I.T. program consists of the following elements.

- Pre-season preparation and training scheduled for June 17 to June 21 2024 aprox. 20 hours. There is no fee for this training. During this time, you will meet members of the staff, learn safety protocols and learn practical boat maintenance and management skills.
- Completion of the *Level 2 Sailing Skills Development* class (aka Experienced Sailor Class) offered during the regular summer sailing sessions. The cost of this two-week class is \$645. The purpose of this class is to help you to develop your individual sailing and boat handling skills. Successful competition of this class (or the equivalent) is a prerequisite for sailing staff members (C.I.T.s and Counselors). You may choose to take this class more than once. Returning C.I.T.s are not required to retake this class if successfully completed in a prior year.
- Student-Teaching: C.I.T.s who have successfully completed the above two prerequisites and have sufficiently demonstrated competency handling the C420s and RS Vision sailboats used at the school may at the discretion of the Sailing School Director be invited to join the team as a student-teacher for the remainder of the sailing season. At this point you will be scheduled for certain classes and weeks of the summer sailing program. On the days you are working as a C.I.T. you will sail in the boat with the students, help them learn to rig, handle and sail the boat and help them follow the directions provided by the Sailing Instructors. This is an exciting opportunity because at this point you will be sailing for the remainder of the supervision of the Sailing Instructors and you will be expected to act as a responsible and productive member of the sailing school staff.

To be selected as a Counselor-In-Training you must:

- Have a positive attitude, follow instructions and willing to help others
- Age 14 or older
- Have a CT Safe Boating Certificate

- Must be a capable swimmer and able to pass an annual swim test before the start of the season
- Have at least 4 weeks experience sailing in previous seasons (combined). This experience can be with Sailaway or another sailing program.
- First year C.I.T.'s will be required to complete the *Level 2 Skills Development Class* (aka Experienced Sailor class)
- Able to demonstrate your ability to handle and sail the c420 and RS vision sailboats used by Sailaway Sailing School.
- Available to attend and complete the pre-season training and preparation June 17 to June 21, 2024
- Available to student-teach as needed between June 24 and August 16, 2024, Mondays to Fridays between 8:45 am and 5:15pm with a one-hour break for lunch. As a C.I.T. you will be scheduled for certain classes and weeks of the summer sailing program. The days and classes for which you will be asked to attend will depend upon the number of students and the staffing requirements for those days and classes.
- Available to help de-rig and put away the sailboats at the end of the season August 19 to August 23.
